OC Bus Service Update

As of the publication of this newsletter, labor negotiations remain ongoing between Orange County Transportation Authority (OCTA) and the union representing the agency's 150 maintenance workers.

After a brief strike in early November, bus service was reinstated. However, according to OCTA, the union said it could call a strike again at any time.

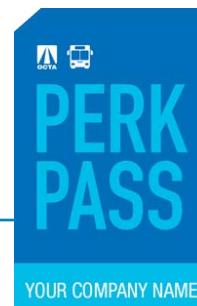
Keep an Eye Out for Your Perk Pass

"Can I Get a Ride Home?"

What Qualifies for a Guaranteed Ride Home (GRH) Ride—and What Doesn't

The **GRH program** is one of the perks that the County offers employees who rideshare. It reimburses you for the cost of your ride home if you need one due to illness or emergency.

You can be reimbursed for a ride home if...

- You or a family member are ill or have a personal emergency.
- Your carpool or vanpool driver leaves early due to emergency or stays at work later due to unscheduled overtime.
- You or your vanpool/carpool driver need to work unexpected overtime.

A few examples of what would not qualify...

- A ride home on a day you drove alone to work.
- A ride *in* to work.
- Rides home due to a natural disaster such as an earthquake.
- Reimbursement due to booking the wrong train ticket or bus pass or purchasing one that you don't use.
- Reimbursement for anyone other than yourself, the employee.

Although you do not need to contact the Rideshare Office prior to scheduling your ride home, you are encouraged to do so if you are concerned whether your emergency will qualify for reimbursement.

Even if you only occasionally ride the bus, you'll need an updated Perk Pass. It allows you to pre-load transit fares—whether monthly passes or per-ride costs—which are automatically deducted when you tap the card to board.



IRS Cap Up \$20

For the 2023 tax year, the Internal Revenue Service (IRS) maximum if you pay for transit and vanpool fares using pre-tax dollars gets a slight bump—from \$280 to \$300 per month.
